Two men armed with Winchester rifles were seen in the vicinity of Irondale, Ala., eight miles from Birmingham, late Wednesday afternoon. Soon after dark they robbed two citizens half a mile from the town. One of the men robbed reported that one of the highwaymen filled the description of RUBE BURROW, the train robber. RUBE BURROW, the train robber, took a ride on the night express train on the Kansas City, Memphis and Birmingham railroad Tuesday night. He was seen and recognized, but no one attempted his capture. He boarded the train, west bound, at a small station in the western part of Alabama, and rode a few miles across the line into Mississippi. He was alone, but carried a large Winchester rifle and two pistols.

Land deeds were created to transfer real property, tax records were used to document the wealth of an individual so that taxes could be collected, court testimony was used to gather evidence to make a decision in a specific case, etc. Why a document was created impacts the information it contains and how reliable that information may be perceived for genealogy research.
