## Beyond Names and Dates: Filling in the Stories of Our Female Ancestors



Pam Vestal is a full-time genealogist and lecturer in Oregon whose research extends far beyond the Pacific Northwest, with clients all over the U.S. and research that reaches beyond our borders.

For most of recorded time, women didn't leave much of a paper trail, but they still had remarkable stories to tell. Although it may appear that they haven't left many documents behind, deeper research into underutilized records will often lead to a better understanding of the women in our family trees. In this talk, we'll explore a variety of records, and also look at local history, the law, politics, and the cataclysmic events that confronted them to help us bring their hidden stories to light.

**Dallas Genealogical Society** --- Have you had the experience of ordering your relative's WWII records, only to get charred and missing pages? On **September 23**, genealogical military expert, Michael L. Strauss, will teach us ways to help reconstruct records lost in the devastating 1973 federal fire.

Session 1 9:30-10:40am The Great War: Researching World War I Relatives

At the beginning of this global conflict, fought between 1914 and 1918, the United States officially declared neutrality. On April 6, 1917, President Woodrow Wilson asked Congress to declare war against Germany and to mobilize the resources of the United States for the fight ahead. By searching for our ancestors' WWI records, we may also learn about the feelings and attitudes of the public towards this conflict.

#### Session 2 10:55am-12:05pm World War II

With the Pearl Harbor attack on December 7, 1941, the United States was plunged into another global conflict. On the battlefield and home front alike, our country mobilized to defeat the Axis powers. Resources include draft registrations, service records, morning reports, as well as records from the home front. This lecture will also feature ways to reconstruct those records most seriously affected by the 1973 fire.

Session 3 12:50-2:00pm Researching the Korean and Vietnam Wars
Following the end of World War II, America became involved in two subsequent wars: the Korean War, fought from 1950-1953 and the Vietnam War (aka 2nd Indochina War), which took place from 1955-1975. The Korean War is often referred to as the twentieth century's "forgotten war", as it was overshadowed by both WWII and the Vietnam War. Resources from all military branches in both wars will

be covered, including service records, draft records and morning records.

Session 4 2:15-3:35pm Tracing the Movements of a Military Unit Knowing where your ancestor's military unit served will help determine the events in which that unit was actively engaged. Understanding the lineage and order of battle for the military unit will assist in knowing the command structure of the organization. This lecture will look at a wide variety of records to trace the steps of military units over multiple war periods.

The answer to many burning genealogical questions can be found buried among the thousands of digitized books available online. In this session we'll explore how to locate books on sites such as Google Books, Internet Archive, HaithiTrust, and FamilySearch Books, and how to use the social, historical, and legal context they provide to advance our research.

Bits & Pieces: Piecing Together Families Despite a Lack of Records

Record loss, deficiencies in record creation, and ancestors who left very few records can leave significant gaps in our family tree. This session will demonstrate alternative strategies for working around the challenges posed by incomplete or missing records to rebuild those missing links and reconstruct forgotten families.
